Subject: FY 2026-2027 Budget Ordinance Amendment

Due to the enactment of **S474 (Session Law 2026-47)**, Harnett County and the municipalities located within Harnett County are now exempt from the provisions of **S889 (Session Law 2026-8)**.

Session Law 2026-47 provides guidance for units of local government that were previously affected by Session Law 2026-8 and that adopted their Fiscal Year 2026–2027 budgets before June 30, 2026. Under **N.C.G.S. § 159-15**, these local governments are authorized to amend their adopted budget ordinances as necessary.

Town staff have prepared a proposed amendment to the property tax rate for discussion at the upcoming workshop meeting. The revised tax rate reflects the approved amended Duke Fire District tax rate, which was approved by Harnett County and is included in the Town's total property tax rate.

BUDGET ORDINANCE AMENDMENT
BOA 2027 – 01
FISCAL YEAR 2026-2027

BE IT ORDAINED by the Governing Board of the Town of Erwin, North Carolina that the following amendments are made to the annual budget ordinance for the fiscal year ending June 30, 2027, pursuant to language in SL 2026-47.

Section 1. This Budget Ordinance Amendment seeks to amend the tax levy approved in the Fiscal Year 2026-2027 budget. This amendment is pursuant N.C.G.S. 159-15.

Section 2. To amend the total tax levy from \$0.67 on each \$100 property valuation to \$.605 on each \$100 property valuation. This includes \$.50 tax rate for general services and a \$.105 tax rate for fire protection services.

Section 3. Copies of this budget amendment shall be furnished to the Clerk, the Governing Board, the Budget Officer and the Finance Director for their direction.
